

Knowspread Terms of Service

Introduction

Thanks for using our products and services (“Services”). The Services are provided by Knowspread.cz s.r.o. (“Knowspread”), located Vítkova 21, Praha 8, PSČ 186 00, Česká republika.

By using our Services, you are agreeing to these terms. Please read them carefully.

Our Services are very diverse, so sometimes additional terms or product requirements may apply. Additional terms will be available with the relevant Services, and those additional terms become part of your agreement with us if you use those Services.

Using our Services

You must follow any policies made available to you within the Services.

Don’t misuse our Services. For example, don’t interfere with our Services or try to access them using a method other than the interface and the instructions that we provide. You may use our Services only as permitted by law, including applicable export and re-export control laws and regulations. We may suspend or stop providing our Services to you if you do not comply with our terms or policies or if we are investigating suspected misconduct.

Using our Services does not give you ownership of any intellectual property rights in our Services or the content you access. You may not use content from our Services unless you obtain permission from its owner or are otherwise permitted by law. These terms do not grant you the right to use any branding or logos used in our Services. Don’t remove, obscure, or alter any legal notices displayed in or along with our Services.

Your Knowspread Account

Your Content in our Services

Our Warranties and Disclaimers

To the extent permitted by law, the total liability of Knowspread, and its suppliers and distributors, for any claims under these terms, including for any implied warranties, is limited to the amount you paid us to use the Services (or, if we choose, to supplying you the Services again).

In all cases, Knowspread, and its suppliers and distributors, will not be liable for any loss or damage that is not reasonably foreseeable.

We recognize that in some countries, you might have legal rights as a consumer. If you are using the Services for a personal purpose, then nothing in these terms or any additional terms limits any consumer legal rights which may not be waived by contract.

Knowspread is using banking services and payment gateway. Fees for these services are not included in the price of Knowspread services and are charged separately. If authors or business partners agreed remuneration is paid, does not include any bank fees and transaction costs.

If it turns out that a particular term is not enforceable, this will not affect any other terms.

The courts in some countries will not apply Czech Republic law to some types of disputes. If you reside in one of those countries, then where Czech Republic law is excluded from applying, your country's laws will apply to such disputes related to these terms. Otherwise, you agree that the laws of Czech Republic, excluding Czech Republic's choice of law rules, will apply to any disputes arising out of or relating to these terms or the Services. Similarly, if the courts in your country will not permit you to consent to the jurisdiction and venue of the courts in Czech Republic, then your local jurisdiction and venue will apply to such disputes related to these terms. Otherwise, all claims arising out of or relating to these terms or the services will be litigated exclusively in Czech Republic, and you and Knowspread consent to personal jurisdiction in those courts.
